

ConnHack Privacy Statement

Preamble

Protecting the individual's privacy is crucial. We have created this Privacy Statement to demonstrate our firm commitment to the individual's right to data protection and privacy. This Privacy Statement outlines how we handle information that can be used to directly or indirectly identify an individual ("Personal Data").

In this Privacy Statement, it is described how personal data is collected, processed, and used for the Hackathon event (hereinafter referred to as "event"). SAP SE, with its registered seat in Dietmar-Hopp-Allee 16, 69190 Walldorf, Germany (hereinafter referred to as "SAP") and Innovationszentrum Connected Living e.V., with its registered seat in Helmholtzstraße 2–9, 10587 Berlin, Germany (hereinafter referred to as "CL") are the hosts of the event, which takes place from 09.–11.03.2018 at the premises of SAP in 10178 Berlin, Rosenthaler Straße 30.

The event shall foster new ideas for energy management systems. The participants will be selected through an application process. They shall i.a. develop data based services, use-cases, and monetization approaches in a playful, competitive environment.

A. General Information

When does this Privacy Statement apply? This Privacy Statement applies to Personal Data that you provide to SAP and CL.

Data Controller. The data controllers in case of the event are SAP with its data protection officer Mathias Cellarius (privacy@sap.com) and CL.

What does SAP and CL do with my Personal Data? SAP and CL will process the Personal Data provided hereunder only as set out in this Privacy Statement. Further Information can be found under Section B.

SAP and CL require your Personal Data to enable you to apply and, in case of a successful application, attend the event. Any provision of this information is entirely voluntary for you. However, without this information it will unfortunately not be possible for SAP and CL to make the event available to you.

Duration of processing of Personal Data. Where SAP and CL are processing, and using your Personal Data under your consent (see B. below), SAP and CL will store your Personal Data (i) only as long is required to fulfil the purposes set out below or (ii) until you withdraw your consent. However, where SAP and CL are required by mandatory law to retain your Personal Data longer or where your Personal Data is required for SAP and CL to assert or defend against legal claims, SAP and CL will retain your Personal Data until the end of the relevant retention period or until the claims in questions are settled.

Why am I required to Provide Personal Data? As a general principle, your granting of any consent and your provision of any Personal Data hereunder is entirely voluntary; there are generally no detrimental effects on you if you choose not to consent or provide Personal Data. However, there are circumstances in which SAP and CL cannot act without Personal Data, for example for an event registration.

Data subjects' rights. You can request from SAP and CL at any time information about which Personal Data SAP and CL process about you and the correction or deletion of such Personal Data. Please note, however, that SAP and CL can delete your Personal Data only if there is no statutory obligation or prevailing right of SAP and CL to retain it. Kindly note that if you request that SAP and CL delete your Personal Data, you will not be able to apply for an event that requires SAP and CL's use of your Personal Data.

If SAP and CL use your Personal Data based on your consent, you may further request from SAP and CL a copy of the Personal Data that you have provided to SAP and CL. In this case, please contact the email address below and specify the information or processing activities to which your request relates, the format in which you would like this information, and whether the Personal Data is to be sent to you or another recipient. SAP and CL will carefully consider your request and discuss with you how it can best fulfill it.

Furthermore, you can request from SAP and CL that SAP and CL restrict your Personal Data from any further processing in any of the following events: (i) you state that the Personal Data SAP and CL have about you is incorrect, (but only for as long as SAP and CL require to check the accuracy of the relevant Personal Data), (ii) there is no legal basis for SAP and CL processing your Personal Data and you demand that SAP and CL restrict your Personal Data from further processing, (iii) SAP and CL no longer require your Personal Data but you claim that you require SAP and CL to retain such data in order to claim or exercise legal rights or to defend against third party claims or (iv) in case you object to the processing of your Personal Data by SAP and CL for as long as it is required to review as to whether SAP and CL have a prevailing interest or legal obligation in processing your Personal Data.

Right to lodge a complaint. If you believe that SAP and CL are not processing your Personal Data in accordance with the requirements set out herein or applicable EEA data protection laws, you can at any time lodge a complaint with the data protection authority of the EEA country in which you live or with the data protection authority of the country or state in which SAP and CL have its registered seat.

B. SAP and CL use my personal data based on my consent

In the following case, SAP and CL will only use your Personal Data as further detailed below after you have granted your prior consent into the relevant processing operations. Therefore, each information about a processing operation with regard to Personal Data is linked to one consent statement in the <http://connhack.org/registration/>. If you re-open this Privacy Statement after you have initially one or more consents granted you will not only see the information related to the consent you have granted but the full privacy statement.

Application process and realization of the event. Subject to a respective provision and your consent, SAP and CL will use your (i) name and (ii) email address, for the selection of the participants in the event and, in case of a successful application, for the realization of the event (registration etc.).

Contacting the Participants after the event. SAP and CL might contact you after the event via email to follow up on the event.

Special categories of Personal Data. In connection with the registration for and provision of access to the event, SAP and CL may ask for information about your health for the purpose

of identifying and being considerate of individuals who have disabilities or special dietary requirements throughout the event. Any such use of information is based on the consent you grant hereunder.

Kindly note that if you do not provide any such information about disabilities or special dietary requirements, SAP and CL will not be able to take any respective precautions.

Revocation of a consent granted hereunder. You may at any time withdraw a consent granted hereunder. In case of withdrawal, SAP and CL will not process Personal Data subject to this consent any longer unless legally required to do so. In case SAP and CL are required to retain your Personal Data for legal reasons your Personal Data will be restricted from further processing and only retained for the term required by law. However, any withdrawal has no effect on past processing of personal data by SAP and CL up to the point in time of your withdrawal. Furthermore, if your use of an SAP and CL offering requires your prior consent, SAP and CL will not be (any longer) able offer the event to you after your revocation.
